

## Policy for the Election of Club Representatives

## Introduction

The Alberta Freestyle Skiing Association Bylaws state as part of Article 4.5:

c) [The Council of Presidents shall:] Elect, in accordance with a process approved from time to time by not less than two-thirds (2/3) of Member Clubs, persons who do not currently sit on the Boards of Directors of Member Clubs to sit as North Club Rep, South Club Rep and Club Rep (together "Club Reps"). Club Reps shall serve for terms of one year or two years, and shall take office at the Annual General Meeting of the Members of the Association.

The purpose of this document is to outline this election process.

## Definitions

Under bylaw article 4.2, it is stated that:

[The Board of Directors of the Association will consist of the following:]

g) Representative on behalf of clubs located in Red Deer and north of Red Deer ("North Club Rep") as may be elected by the Council of Presidents from time to time

h) Representative on behalf of clubs located south of Red Deer ("South Club Rep") as may be elected by the Council of Presidents from time to time

i) Representative on behalf of all clubs ("Club Rep") as may be elected by the Council of Presidents from time to time

## **Election Procedures**

- 1. In advance of the annual general meeting, the council of club presidents will be asked to provide up to 3 suitable candidates per region (north and south) that are willing to perform the duties of a club rep and are not current board members of their member association.
- 2. Candidates will be asked to provide a brief biography of their experience with the Alberta Freestyle Community for consideration by the Council of Presidents.
- 3. Each voting club will be allowed 2 votes per club: one for the selection of a north rep, and one for the selection of a south club rep. This will ensure that there are equal amounts of votes in both the north and south pools of clubs.
- 4. The candidate that receives the most votes overall will be elected the **Overall Club Rep**, regardless of which region they represent. The most votes received by a southern candidate will be elected the **Southern Club Rep** and the most votes received by a northern candidate will be elected the **Northern Club Rep**.
- 5. As per the bylaws, the resulting candidates will be presented as part of the board at the AGM. Subsequent elections shall take place at the Council of Presidents prior to the annual AGM.
